# THE FIRST STEPS:

### **Who Swept Your Camp?**

In Portland, Oregon, the City has contracted Rapid Response BioClean to sweep homeless camps and manage property taken in the sweeps.

The location where your seized property is stored changes often. *Call* to ask for the current location.

### What Is The Timeline For Retrieving Belongings?

You have to wait 24 hours after the sweep for your items to be processed before you can retrieve them. You may be asked to provide proof its your property. Items are often thrown away.

## WHAT IS CONVERSON:

#### What Is Conversion?

Conversion is when a party takes property from another with the intent to deprive them of it.

Basically, if someone takes or destroys something you own, they are depriving you of it - whether or not they know the item has an owner.

With conversion, *intent* doesn't mean just stealing, it is still conversion even if they believe the item has no owner.

### How Do You Know If Conversion Happened To You?

If your property has been thrown away, destroyed, given to another person, or they refuse give to you your property, that is conversion.

### What Is Your Next Step?

Conversion is a tort law. This means you have a 2 year time frame to file your claim, get a tort lawyer and sue to recover your property or be compensated.

### IF YOU THINK YOU HAVE A CLAIM, GET A LAWYER

# PREPARING FOR COURT:

#### **What Should You Expect?**

The court systems is tough and its important to know that going into it. If you lose you may be on the hook for the defense's attorney fees. That does not mean you shouldn't go to court, but you should be prepared.

Make sure to discuss preparation for trial with your attorney.

### **How Should You Prepare?**

DO NOT REPRESENT YOURSELF, get a lawyer.

ALWAYS show up to court dates, you will automatically lose if you don't show up.

IF YOU NEED ONE, remote trials hosted online or on a call are available if you don't want to be in the same room as the defendant or can't conceivably make it to court.

ALWAYS keep your attorney's info on you. If there is a emergency and you can't make it to court, you need to tell your attorney ASAP or you will default.

IF YOU WIN YOU DON'T PAY ANYTHING. for small claims under 10,00 dollars, if you we the defense pays your attorney fees
